"Social impact & Civil Economy Framework"

<u>Social impact assessment analysis.</u> A sociological perspective: Measuring and evaluating the social impact of development and cohesion policies, from a sociological perspective, means, first of all, drawing on the methodological tradition of social research and then on qualitative, quantitative and mix methods. It means using all of them with an innovative perspective, trying to understand social change starting from the effectiveness of institutional interventions, the role of citizenship especially in fragile contexts. All this in response to the new needs and expectations of post-modernity and within the greatest and most complex change of social relations.

<u>Civil Economy Framework - social innovation, new entrepreneurship and the role of local communities</u>: Nowadays socio-economic institutions change is strictly requested by scholars, politics and - overall - by common people too. This kind of innovation regards public policies at the macro level, also concerning social practices and organizational models at micro level. It must be characterized by a similar vision and converging purposes. For this reason, we need of a practical and theoretical framework that allows this kind of change that procures a different kind of cohesion and development.
